Technical Committee Wednesday, April 13, 2011 10AM

I. Call to Order/Welcome. Chair Shelley Wright of Vulcan Materials called the meeting to order at 10:05 AM. Other members in attendance were Bill Carwile, Lynchburg Ready Mix; Allison Corrigan, Lafarge; Eric Misenheimer, Chandler Concrete; Chuck Starnes, F & R; Scott Manning, Titan America; Hank Keiper, The SEFA Group; Tom Wahl, The SEFA Group; Darrell Wilson, Boral; George Kuhn, Chandler Concrete; Bob Neal, Lehigh; Bob Swope, Swope & Associates; Patrick Pearce, Vulcan Materials; Kevin Vaughan, Vulcan Materials; Teck Chua, Vulcan Materials;

and Henry Prenger, Lafarge. Keith Beazley, George Boykin, and Bob Nablo represented the staff.

- II. Anti-Trust Statement. Wright reminded everyone that by signing the sign-in sheet they acknowledge that they read and agreed to the Anti-trust Statement.
- **III. Approval of the Agenda.** On a motion by Wilson and a second by Patrick the Agenda was approved unanimously.
- **IV. Approval of the January 12, 2011 Minutes.** On a motion by Wilson and a second by Pearce the minutes were approved unanimously.
- V. Residential Code. The 2009 Residential Code has been approved and released. This means that ACI318-08 is in. A discussion on ACI 318 Table 4.2.1 Exposure Categories and Classes ensued. On a motion by Neal and a second by Wilson, passed unanimously, a subcommittee consisting of Bob Neal, Teck Chua, Hank Keiper, Chuck Starnes, and Henry Prenger was formed to develop a training session on the use of Table 4.2.1. Prenger added that ACI 301 is looking at adding something about ASR. Neal states that Technical Bulletin #6 is complete and is now on the Association website.
- VI. Color Concrete. On a motion by Neal and a second by Wilson, passed unanimously, it was decided the information provided by Sammy Davis

would be put in the Association Newsletter as a technical article by Davis and then be posted on the website.

VII. VDOT use of Mineral Fillers. On a motion by Prenger and a second by Patrick, passed with 3 abstentions, it was decided that the presentation given by Vaughan would be forwarded to VDOT as a proposal using Association letterhead.

VIII. VDOT/VRMCA Co-Op Meeting. NRMCA Truck Inspection are being accepted by the VDOT Districts as follows: Richmond, Lynchburg, and Culpepper are using it; NoVa will accept it but requires tags with the expiration date; Salem will accept with a list of certified trucks; Hampton Roads, Fredericksburg, Bristol, and Staunton have not indicated what they will do. The proposed wording for ERS trial batching is attached. Wright and Larry Lundy of VDOT are working on the wording for the use of pozzolans for use in concrete patches. Neal will make a presentation at the next Co-Op meeting on heat modeling for use in VDOT's Mass Concrete Special Provision. The next Co-Op meeting will be on July 26, 2011.

IX. EPA Fly Ash Status. Keiper reports that the EPA will not make a determination until later than 2012.

X. New Business. Chair Wright informs that due to increased duties with Vulcan she will resign as Chair after the July 26, 2011 VDOT/VRMCA Co-Op meeting.

XI. Next Meeting Date and Location. Next meeting will be July 13, 2011. Same location.

XII. Adjournment. On a motion by Wilson and a second by Kuhn the meeting was adjourned at 1:10 PM.
